A. CALL TO ORDER

D. DISCUSSION OF A LANDSCAPING PLAN AND TREE PLANS FOR OASIS PARK

Member Bohm said he reviewed the Teska's landscaping plans for this area. However, Member Bohm suggested we wait until it is determined that the area drainage problem has been resolved prior to planting anything. Afterall, planting can occur in the spring. Member Towne asked Member Bohm to create a plant list for the January Committee meeting to begin the planning process and to go out to bid.

Member Bohm said he did some research and found the landscaper's name who did the native planting in the North Park for Lincolnshire. Member Bohm said he will follow-up with this landscaper to discuss Mettawa's planting needs.

Member Bohm asked if the Perfect Cut's approval to remove the buckthorn had been completed because the work was not getting done. Member Towne said yes, the work was approved. Adrian has been waiting for the rain to stop in order for him to catch-up on the back-logged jobs.

E. DISCUSSION TO ADD A PICNIC TABLE AT WHIPPOORWILL PARK

Member Towne said the picnic table would need to be placed on the patio. Village Administrator Irvin said the picnic table is on sale right now for \$589 and \$180 for shipping and delivery. Member Bohm said the people in this area are interested in walking not stopping for lunch. Member Towne said the trails are enticing for walkers, we currently do not have a need for a picnic table.
