The Buzz Safety Basics & Tips

Many suburbs around Chicago have seen crime rates increase in recent months. As a preventative measure, we urge all Mettawa residents to be aware and practice smart safety.

At the Village level, resident and property safety continue to be top priorities for Village officials. The Mettawa Public Safety Patrol (Howe Security), overseen by the Public Safety Commissioner, Trustee Carol Armstrong, has kept a responsive eye on our community.

Trustee Armstrong also maintains strong ties with the Lake County Sheriff's department, two fire protection departments (Countryside and Lincolnshire) and the Village Alert System (Blackboard Connect).

At the individual level, Trustee Armstrong emphasizes that residents play a powerful role in community security. She says, "Let's all get back to basics, keep our eyes and ears open, and look out for each other."

I hope 2022 is filled with health and happiness for you and your family.

Our Village is stepping into

this new year in good financial health. The Village Board and I share a strong dedication to fiscal responsibility and work hard to reduce financial burdens on our residents. As a result, Mettawa is the only municipality in Lake County (and one of only a few in Illinois) that has maintained a low (\$135,000) tax levy for over twenty years.

As your Mayor, I regularly talk to residents about many topics, and public safety is one of my top priorities. I am supporting key budget allocations for increased public safety funding to contribute to greater security and provide our community with greater peace of mind. We have also improved cyber security for the Village by making our cyber insurance more robust. This change will better protect our online resources, including emails, online networks, and data storage.

TIP 1: Install "No Solicitors" sign

We recommend placing a "No Solicitors" sign on your mailbox and/or door. The Village provides these free signs to residents by request to the Village Clerk.

Did you know that solicitation is not allowed in Mettawa without a Village-issued solicitation permit? These permits are extremely rare (in the past six years, Mettawa has only issued one), and if/when a permit is issued, the Village will notify residents.

Without a permit, it's not legal for people to come to your door to offer goods and/or services. This means that if anyone knocks at your door to offer window upgrades or roofing services, or any other solicitations, they are breaking the code of the Village's ordinances.

TIP 2: Take control: Don't open the door

If a stranger comes to your door, do not open the door to speak with them and do not let them into your house.

Keep your door closed and locked. You can talk through the door to communicate. If they can't hear you, ask them to call you. If you have an installed camera/speaker system use it. Anytime you don't feel safe, or if something just seems "off," call 911.

This same principle applies to anyone anywhere on your property. Even if you have an alarm, if you see a person or group of people who do not belong on your property (or your neighbor's property) call 911.

Also exercise precautions with standard service providers. At times, Comcast or Nicor associates may come to your door or onto your property for valid reasons. Instead of opening the door, ask them to call you. You can also call the firm directly to validate their activity. Please note that the Village will notify residents ahead of time when a utility visits an area.

Remember, if you see something unusual, don't open the door; call 911.

TIP 3: Going out of town: Schedule Mettawa Public Safety house checks

Mettawa Public Safety will do complimentary house checks by request. Before you go out of town, just let them know you'd like to to be added to the schedule.

(847) 404-6272. We invite all residents to take advantage of this valuable free house check service.

Public Safety Officer Antonio Soto notes, "Don't be afraid to call us. We'll check your house whether you're gone a day, a month or even years. We'll even help with packages and garbage cans, but we don't do window cleaning!"

Most municipalities require residents to pay out-of-pocket for security checks, but the Village offers it to residents at no charge. One phone call is a small price to pay for increased safety and peace of mind.

SUMMARY: We all play an important role

The Village is working with Mettawa Public Safety and the Lake County Sheriff to increase their presence and vigilence in our Village, and research studies have shown that vigilant, involved communities show reduced crime rates.

You can help. Take proactive measures, like adding motion lights or a security camera doorbell. Stay aware and look out for yourself and your neighbors. Together we can make a difference. \$

St. Marys Road Construction

Administrator's Report

It's the time of year when we work on financial planning. I'm pleased to announce that the Village has once again approved the tax levy for 2021, holding it at the same level it has been for the last twenty some years. Mettawa is proud to be one of the only municipalities in

the state to keep the tax levy at a steady rate without increase. Budget planning has begun for the fiscal year 2022-2023. We are assessing capital improvement projects and looking at financials. A full draft budget will be presented to the Finance Committee during its March meeting. It should be quite similar to the current budget. After the meeting, a proposed budget will be posted on the Village website. On April 19, 2022, the final budget will be presented to the Village Board at a public hearing.Please feel free to reach out to me with any questions. *

New Trees at Oasis Park

Since the first tree was planted at MacLean Preserve at Oasis Park in November 2021, the Village has received many resident requests for tree plantings on the berm. In response, six "trial run" trees have been planted, including three Eastern Red Cedar and three Arborvitae. "If these native trees thrive in this location, we'll plant more in the future," says Trustee Denis Bohm, the chair of the Parks and Recreation Committee. *
