Mayor's Note

Village safety

The foliage color changes lately have been beautiful. I hope you've enjoyed this fall season.

It was great to see so many

neighbors at the Village picnic in September. We live in a unique community, and I'm dedicated to keeping Mettawa a great place to live and work.

Village safety is my top priority, as I continue to explore options to increase law enforcement presence throughout the Village. I have been working closely with the Public Safety Commissioner, Carol Armstrong, to evaluate all possible options. Mettawa will maintain full time coverage with Howe Security and you will continue to see our officers, Rick and Antonio, patrolling the streets.

In addition to Mettawa Safety Patrol, I have requested special details from the Lake County Sheriff's Office through this winter. The hours and days will vary each week, so remember to keep your speed lawful, as they will be issuing tickets to speeders. The special details will continue until we are able to secure a full time deputy from the Sheriff's Office in 2023.

Because crime does not respect municipal boundaries, Mettawa is also a member of the North Shore Burglery Taskforce, a specialized unit that collaboratively compiles information across all North Shore communities.

Clear your culverts to avoid soggy landscapes and flooding

The colorful autumn leaves shine brightly except when they collect in culverts. Fallen leaves and branches tend to block drainage outlets, cause curbside puddles, soggy lawns, sodden pathways and can even contribute widespread flooding.

You can make a difference. Winterize your culverts this fall by clearing waterlogged blockages. This simple task supports better stormwater drainage. By taking action to remove debris, you'll help Mettawa's water flow freely and will probably avoid problematic backups in your own backyard.

The fall task of cleaning a culvert is relatively uncomplicated and quick. Simply pull out larger pieces by hand (i.e., sticks and branches) then remove smaller debris (i.e. leaves) with a rake or hoe. *

Public Safety Commission Update

Snow plowing

After extensively reviewing bids from multiple contractorsfor snow plowing services, the Village Board approved a contract from Forest Builders to cover the coming winter season. This contractor has plowed Village streets for a decade and well knows Mettawa's needs and terrain, so we anticipate no change in service.

Municipal elections: April 4, 2023

Open positions: The Village of Mettawa will be accepting candidate nominations to fill the open positions of three (3) full-term Trustees and one (1) 2-year term.

Petition filing period: Monday, December 12th to Monday, December 19th, 2022

How to file a petition: All candidates seeking office at the consolidated elections on April 4, 2023 must file petitions with the Village of Mettawa during the petition filing period, December 12-19, 2022. Filing will conclude at 5 p.m. on Monday, December 19th. Petition packets are available at the Village office weekdays during office hours, and can be mailed to residents upon request. The Village office will be open on regular business days beginning on December 12th (9:00 a.m. — 12:00 p.m.) with additional office hours of 1:00 p.m. to 5:00 p.m. on Monday, December 19th.
