Village Board Trustee Jan Pink and Zoning, Planning and Appeals (ZPA) Chairman Joe Krusinski will both retire in May. These honored Village residents have given many years of dedicated service to Mettawa as volunteer officials. We proudly celebrate their time and contributions to our community.

Jan Pink

A resident since 1978, Jan and her husband Ron were introduced to Mettawa's peaceful way of life by a friend.



They loved the 5-acre lots, trees and wildlife, and decided to make the Village their permanent home. Over the years, they built two houses here.

Jan recalls, "When I first saw a doe and her two fawns in our backyard, it was surreal, like a movie." Her husband Ron told her, "We don't need a second home in Florida or

Wisconsin, because you have it right here."

Jan added, "Another reason we love living here is that we have had Great Danes all our lives. More people knew our dog, Angel, than Ron or me. She loved it as much as we did."

Over the past ten years, Jan served in many important roles: Village Board Trustee, Safety and Security Commissioner, Parks and Recreation Committee member and Public Works Committee Chairman. One of her proudest achievements was when Mayor Urlacher announced that Grainger was coming back into the Village."

We asked Jan what initially inspired her to get involved with the community. She emphasizes the importance of contributing: "I believe in giving back to the Village, the area you live and love. I feel that

Jan leaves these words of wisdom for future Village officials: "Never have a personal agenda. Always do what is right for the majority of our residents."

Joe Krusinski

A Village resident since 2006, Joe is an Executive Member of Krusinski Construction Company. He moved to Mettawa with his wife Kay after living in Lincolnshire for 30 years. They were the first to buy



land and build a custom home at Deerpath Farm, paving the way for others to appreciate the "idyllic environment we are blessed to have in Mettawa."

The mayor at the time, Mayor Jess Ray, quickly recruited Joe onto the ZPA Commission. As Joe recalls, "It was hard to say no to Jess, and he

said the ZPA met on very rare occasions as matters arose ... a bit of an understatement on his part!"

Joe also notes, "I am very proud of the fact that Mayor Urlacher asked me to continue in my role as Chairman of the ZPA. I am also very pleased that I have enjoyed a trusting relationship with the Village Mayor, Trustees, attorney, and staff these many years on the ZPA. It goes without saying that I cannot thank the past and present ZPA Commissioners for their efforts and enormous contribution of time to complete the work of the ZPA."

One of Joe's major accomplishments was leading a collaborative effort over countless hours to enhance and upgrade the zoning codes and make a final recommendation to the Village Board for the Mettawa Zoning Ordinance. He says, "I am personally very proud of our work and share that pride with all those that contributed to it."

Noting the parallels between business processes and municipal efforts, Joe leaves these words of wisdom for future Village officials:

- 2. Everyone needs to abide by the reached agreements,

Considerations for Spring Cleanup

When spring arrives, it's time to freshen up our neighborhood's outdoor environment. You'll soon see trucks and workers around the Village tackling potholes, refreshing trails, and clearing Village culverts to remove debris and allow the water to



flow more freely.

If your property includes a culvert, we encourage you to add culvert cleaning to

your spring tasks too. A little time spent clearing debris now can help you avoid inconvenient overflows later.

Please note, burning is not allowed without contacting/notifying the Libertyville Fire Department. They assess the season/dryness and wind speed and will tell you if it's a good day to burn or not. NEVER start a fire close to the trees, the neighbors property or leave it unattended.

Administrator's Report

The Village Board approved the annual budget for fiscal year 2023-2024 at its meeting on April 18th.



Our Village Board prioritized keeping the property tax rebate at the same amount as last year, rather than reducing the amount. This budget continues to maintain all Village services with no increases to existing taxes.

Over time, the tax rate generally


goes down with an increased total assessed valuation when the tax levy remains the same. For the 25th consecutive year, Mettawa's property tax levy will remain the same at \$135,000. It is a testament to the Village's fiscal stability and strength that we have been able to hold our levy steady for 25 years and continue to issue a property tax rebate at such a large amount.
