New Village Property Restoration

Recent open space progress at the corner of St. Marys Road and West Old School Road

While driving along St. Marys Road, you may have noticed some recent changes to the landscape at 15085 West Old School Road. About 16-20 feet of buckthorn was removed along the perimeters of the property.

The Village recently acquired this parcel. The Parks and Recreation Committee proceeded with cleanup almost immediately, focusing primarily on the invasive buckthorn overgrowth that had overtaken the land.

Parks and Recreation Committee Chairman, Trustee Wendie Clark, notes, "It was nearly 1.5 acres of buckthorn! Now that it's been cleaned up we're ordering some Norway Spruce and Red Maples to plant along the St Marys Road side. We plan to let the grass grow and see what else comes up. Perhaps

Trustee Clark shared more good news about this restoration project, "We qualified for recognition by the Lake County Forest Preserve for a flag showing the Old School property is buckthorn free."

Open space restoration continues at Mettawa Savanna

The ongoing restoration project at the Mettawa Savanna project has

also made great progress. This land is now free of buckthorn. Soon the the remaining few piles of metal and brush debris will be removed and a Village gate will be installed.

Trustee Clark notes, "We expect the farmer, Bob Haraden, to plant organic soybeans as soon as the weather cooperates."

New Village map will include Everett Pond and Mettawa Savanna

New Village maps are being created to reflect the boundaries of all current municipal properties, including the two recently aquired sites at the intersection of Everett Road and Riverwoods Road. These parcels have new names: Everett Pond (on the northeast corner) and the Mettawa Savanna (on the northwest corner). *

Springtime is Culvert Cleaning Time

Spring brings flowers, fresh air, frogs and sometimes a little bit of mud. Spring-cleaning isn't just for indoors, it's a great opportunity to tidy up outdoor spaces too.

For the many residents, spring cleaning includes cleaning culverts. Removing culvert debris helps water to flow freely without unsightly clogs or soggy buildup.

If your property includes a culvert, do yourself a favor by adding culvert cleaning to your spring tasks. Removing debris now can help you improve water flow and avoid messes later. *****

Burning? Ask the Fire Department

If you plan to burn, please note that burning is not allowed without notifying the Libertyville Fire Department. The LFD experts assess the season,



dryness and wind speed and can tell you if it's a good day to burn or not. Make sure to never start a fire close to trees or a neighbors property, and never leave a fire unattended. \$

Public Works Committee Projects

The Public Works Committee takes on a lot of important work every spring.

For example, the Village recently

finished removing dead trees from right-of-ways. This yearly project significantly improves roadside safety and aesthetics.

This spring we'll see more improvements to our village infrastructure, including crack sealing on roadways and renovation of ditchs and culverts.

Crack sealing protects Village roads from further water damage and, more importantly, protect the underlying roadbed.

The Public Works Committee Chairman, Trustee Sweb Smolic, explains, When time comes to resurface all of our village streets, it will be a lot less expensive if the roadbed underneath is not damaged."

Last fall, all ditches and culverts were cleaned professionally to remove decades of mud and gravel buildup. Trustee Smolic notes, "This year we will be repairing and replacing any village culverts that need it."

Lake Forest Beach Passes and Program Classes

Once again, Mettawa residents have the opportunity to purchase a Lake Forest beach parking pass for \$85. The permit provides Upper Lot Access to Forest Park Beach. Simply complete an application and return it with payment to The City of Lake Forest, 800 N. Field Drive, Lake Forest, IL 60045. Administrator's Report

The Village Board approved the annual budget for fiscal year 2024-2025 at its meeting on April 16th.

Our Village Board prioritized keeping the property tax rebate at the same amount as last year, rather than reducing the amount. This budget continues

to maintain all Village services with no increases to existing taxes.

Over time, the tax rate generally goes down with an increased total assessed valuation when the tax levy remains the same. For the 26th consecutive year, Mettawa's property tax levy will remain the same at \$135,000. It is a testament to the Village's fiscal stability and strength that we have been able to hold our levy steady for 26 years and continue to issue a property tax rebate at such a large amount.
